

# Social Determinant of Health Z Codes For HealthySteps and HealthySteps-Aligned Services

## About This Document

---

Z codes are a set of ICD-10-CM<sup>1</sup> codes used to report social, economic, and environmental determinants known to affect health and health-related outcomes. Any member of a patient's care team can collect social determinants of health (SDOH) data during any encounter, including behavioral/mental health providers, community health workers, case managers, patient navigators, and nurses. SDOH data may be documented in the patient's medical record, where this data can be translated into one of the ICD-10 Z codes that represents the information collected.

Many of the SDOH Z codes can be used to identify a range of issues such as those related to education and literacy, employment, housing, and the ability to obtain adequate amounts of food or safe drinking water.

Below is a list of the current ICD-10-CM social determinants of health Z codes that can assist a HealthySteps Specialist in cross walking their collected data into diagnosis codes.

<sup>1</sup> ICD-10-CM refers to the tenth edition of the International Classification of Diseases, which is a medical coding system to catalog health conditions by categories of similar diseases under which more specific conditions are listed. It is a diagnosis code set used for all healthcare settings.
