
Helpful facts

HealthySteps (HS) in CO timeline




When a barrier becomes an opportunity...

Growth and Expansion

- Growth within health systems

 - Denver Health, CHCO, Kaiser, Every Child Pediatrics

Manatt Scaling Plan – Funded by ZOMA

- 2019 ZOMA wanted to make a "catalytic" investment
- Paid for a National Consultation (Manatt Health) to develop a strategic scaling and sustainability plan
- Questions:
 - What systems and supports need to exist to support state-wide scaling?
 - What is the role of the State Intermediary and the National Office?
 - What does scale look like in the next 5 years?
 - What funding opportunities are available to sustain the model (including Medicaid but also beyond Medicaid)

HealthySteps Colorado Undertook an Intensive Expansion and Sustainability Planning Effort

- ZOMA Foundation, in coordination with ABCD, engaged Manatt Health to undertake a four month intensive planning process from July to October 2019
- Comprehensive process involved:
 - Detailed accounting of Colorado's current HealthySteps operations and finances;
 - 25+ stakeholder interviews with existing HealthySteps sites in CO; local private funders; state Medicaid, Human Services and Executive Office officials; providers; and early childhood advocates, among others to assess:
 - Familiarity with HealthySteps;
 - Role of HealthySteps in helping the State to meet key goals;
 - Areas to target for expansion; and
 - Potential funding
 - Financial modeling to estimate costs and revenue needs to sustain proposed expansion
 - Close review of state intermediary's current functions
- Throughout the planning process, Manatt Health worked with the ZOMA Foundation and ABCD to develop recommendations

Vision for Expansion & Sustainability Builds on Current Efforts to Meet Children & Families' Needs

Building on HealthySteps' track record and strong interest among stakeholders, ABCD, with funding from ZOMA Foundation, undertook an expansion and sustainability planning effort to meet the following goals:

- Proactively scale HealthySteps to reach a broader population of high-needs children across Colorado in both rural and urban areas
- Identify target geographies and practice types within which HealthySteps expansion would most effectively reach at-risk children and maximize HealthySteps' impact
- Highlight the role of HealthySteps in helping Colorado to meet key goals, including putting young children on a path to success, strengthening coordination between the health care and early education sectors, and integrating physical and behavioral health
- Leverage public and private resources to enable growth and sustainability of HealthySteps

Proposed HealthySteps Expansion Plan: Broadening Reach While Balancing Sustainability

- Outlines how Colorado can expand HealthySteps in a sustainable way to serve at least 20% of children ages 0-3 statewide—more than tripling current penetration
- Increases HealthySteps presence in both new and existing counties
- Uses publicly available data and extensive stakeholder feedback to identify targeted expansion areas based on high demonstrated need for the unique set of supports and services HealthySteps offers
- Approaches expansion with an equity lens, expanding further within urban areas while also branching into rural areas
- Accounts for potential funding opportunities to ensure HealthySteps is expanding in a cost-effective and sustainable way
- Assumes growth of state intermediary capacity to enable successful execution of expansion and sustainability plan
- Identifies FQHCs and other integrated clinics as strong site candidates, but leaves specific clinic selection open to ensure community buy-in and provider readiness

Expansion means adding a new location within an existing health system, adding another HealthySteps Specialist to an existing clinic to serve more children, or adding a HealthySteps Specialist into a new clinic

Plan Takes Comprehensive Approach to Identifying Target Communities by Assessing Community Need



Areas with a critical mass of young children



Risk, Reach and Resources (RRR) Report's "Childhood Mental Health Relative Risk Score" (e.g., adults with high ACE scores, children living under 200% FPL, substantiated abuse or neglect claims, maternal depression, etc.)



Areas with child care capacity gaps



Presence of existing care models and/or initiatives where HealthySteps could align



Provider-specific information (e.g., FQHC network, physician champion)

Factors identified based on review of publicly available data and extensive stakeholder feedback

By 2024, there will be 27 new HealthySteps sites for a total of 42 sites statewide

HealthySteps will serve nearly 1/3 of all children ages 0-3 in counties with HealthySteps sites and more than 20% of all children 0-3 statewide,*** more than tripling its current penetration

HealthySteps provides all families identified as at-risk with intensive services; ~17% of its families require these services


Projected budget to operate 42 sites is \$5.3 M to ensure both sites and intermediary are operating at full capacity

Our progress so far...


Growth

- 29 site across Colorado (some attrition)
- On track to onboard 1 new sites fall 2023
- On track to onboard 7-9 new sites in 2024
- Added 2 new large health systems
- HealthySteps expansion in Denver-metro
- HealthySteps expansion in rural regions (2 new counties)
- Currently serving about 40,000 children statewide (almost to 20%!)

Sustainability

- Stable state funding (even during COVID budget cuts)
- Ongoing funding for state intermediary
- Federal funding to support broader work
- Ongoing conversations with state Medicaid as they develop the Pediatric Alternative Payment Model and launch Colorado's Accountable Care Collaborative 3.0 (2025)
- Support from multiple state government entities and philanthropy
